



Minutes of Tower Grove Heights Neighborhood Association Meeting – May 22, 2018
Convened: 7:20 p.m. Adjourned: 8:30 p.m. 40 attendees

Meeting chaired by TGHNA President, Vicky Dean (president@towergroveheights.com)

- **Opening of meeting and welcome**

- **Neighborhood Reports**
 - **In lieu of the 15th Ward Aldermanic and STLMPD Liaison reports, we used the time for a Participatory Budgeting general assembly conducted by volunteer and TGH resident, Mia Salamone**
 - \$100,000 from the 15th Ward budget will be set aside for capital improvements voted on by residents. The first step was to brainstorm ideas for projects in small groups and list them on several large sheets of paper. Next, suggestions from the lists were presented to the whole group. Finally, each attendee was given three stickers to put next to the ideas indicating their votes for particular projects. Similar suggestions will be tallied together. The suggestions that garner the most votes from the three general assemblies held in the ward will be researched for feasibility/cost and voted on by residents at the same time as the midterm elections in November. The projects that receive the most votes will be funded as funds allow.
 - Suggestions included:
 - ✓ Sidewalk repair/Increase allocations to the 50/50 sidewalk repair program
 - ✓ Traffic/Security camera(s) (especially on Gustine)
 - ✓ Additional recycling dumpsters in alleys
 - ✓ Speed humps near beginning and end of blocks, instead of only one per block
 - ✓ Strategy for more flowering trees to be planted
 - ✓ Alley paving
 - ✓ Pedestrian-scale lighting along blocks
 - ✓ Flashing pedestrian lighting at intersections
 - ✓ Porch light assistance grants
 - ✓ Public art
 - ✓ Additional “Little Libraries”

 - **SLMPD 2nd District update – no report (see attached crime statistics)**

- **Speaker: Paul Lynch, St. Pius V Parish Council**
 - Paul Lynch and the Reverend Paul J. Niemann, Pastor, St. Pius V Parish Council, recently spoke to the TGHNA board about a proposal by Assisi House (www.assisihouse.org) (see attachment) to rent St. Pius V’s former convent to house previously homeless men. The board invited them, along with some Assisi House officials to this general meeting to answer residents’ questions:
 - ✓ Mr. Lynch, along with Father Niemann, some TGH residents who are parish members and Assisi House board members, attended this meeting and spoke about their proposal:

- ✓ *Since the last of the nuns have now moved out of the convent at St. Pius V (3310 S. Grand), the Roman Catholic Archdiocese of St. Louis approached St. Pius V to discuss locating the fifth Assisi House there. (There have been four other Assisi Houses in St. Louis, all of which are located in north city. The group is associated with St. Louis Winter Outreach, which works with the owners of Mokabe's Coffeehouse, 3606 Arsenal.)*
- ✓ *Fr. Niemann and Mr. Lynch are seeking input from the surrounding neighborhood associations: Tower Grove East, Tower Grove Heights and Tower Grove South. By law, they will also seek 51 percent of signatures from residents within a 500-foot radius of the convent approving the project.*
- ✓ *St. Pius V does not want to sell the building so they are offering a two-year lease to Assisi House.*
- ✓ *St. Pius V would be minimally involved but major repairs to the building would be their responsibility.*
- ✓ *The plan is to start with 17 residents to shelter there and then winnow that number to 13 for permanent residency after six months. Each man will have his own room and locker. Meals will be communal.*
- ✓ *Residents of Assisi House will receive a bus pass and help with medical /dental care and will be expected to pay a modest monthly rent of \$250.*
- ✓ *Residents are expected to be out looking for work during the day and will not be loitering in the area.*
- ✓ *Residents will be chosen from a pool identified as "ready to make the transition from the streets to housing." Drugs, smoking and criminal activity will not be allowed. Residents may have been convicted of misdemeanors but not felonies.*
- ✓ *A TGH resident suggested that they need to get a variance to run the operation as a boarding house.*
- ✓ *Although a formal vote to support the proposal was not taken, attendees appeared to approve the proposal so TGHNA will draft a letter of support.*

Assisi House at St Pius V Parish

We propose to open the St Pius Convent as Assisi House 5 in mid-November for 15-16 men. These men will be selected by a working committee consisting of professional social workers on behalf of Assisi House, in collaboration with referral sources at other agencies such as St. Patrick Center, Sts. Peter & Paul, and other social service agencies. We will choose these men carefully based on our committee's judgment regarding their suitability for living in a communal setting.

For four months—from mid-November to mid-March—we will operate as an all-winter shelter. The residents will have a rent-free period, will enjoy two meals a day, be given monthly bus passes, and be provided a locker space to guard their personal effects, documents and valuables. They will be allowed to arrive at the house at 5:00 PM and stay until 8:00 AM every morning except Sunday, when they will be allowed to stay in all day if they wish. During this four-month period, there will be paid staff or volunteers present whenever there are residents in the house. House rules are extensive and strict. Residents are not allowed to smoke, drink alcohol, use drugs or be in possession of a weapon of any kind in or anywhere near the house. Violation of these rules will result in immediate expulsion. In mid-March, we will convert the facility to permanent supportive housing for 13 men. Each resident will have an individual bedroom, lockable and secure. Residents at this time will begin to pay rent in the range of \$200-250/month. Their rooms are their homes, and they share the common facilities. At this time, we will shift from staffing in the house to outside management, with one of the men serving as a resident manager. Assisi House Inc. will remain responsible for the operation until and if the parish wishes to assume a more active and direct role in management of the house.

Assisi House


When you don't have a job, you can't pay the rent

Assisi House provides breakfast, supper, and a bed, so those who are unhoused can get on the with the business of living.



Assisi House:

a safe place to live while getting on with the business of living.



In 2005 a group of volunteers organized the **St. Louis Winter Outreach (SLWO).**

SLWO's mission is simple: to prevent unhoused people from dying from the cold during the coldest nights of the winter. We began by reaching out to the homeless with blankets, food, water and supplies; transporting people to existing shelters; and then building a network of eight emergency shelters to house people on especially cold nights. This work continues today.

After almost 10 years of Winter Outreach, we recognized that we could do more, even as an all-volunteer organization.

We formed Assisi House Inc. in 2014 to provide an every-night, all-winter shelter for 27 men. At the end of the winter it was converted into permanent housing for 13 men who pay an average of \$250 per month. This endeavor was so successful that an additional Assisi House was opened in each of the following three years. Two of the houses are for women and two are for men. All four are still operating.

The goals of Assisi House:

- By providing our residents with the basic needs of food, shelter, transportation and a secure place for their belongings, we allow them to focus on issues in their lives that have caused them to be homeless.
- By providing these basic needs in a small community setting we help create an atmosphere which is safer and much more supportive.
- By converting these small community shelters into permanent very affordable housing, we provide a transition that some residents need before moving into independent living, and others may need indefinitely due to disabilities or other issues.

Assisi House Inc. is unique because we provide housing both for transitional and permanent occupants with personal accompaniment, in an organization entirely funded by non-governmental sources.

Assisi House & St Pius V Parish
 St Pius V Church at Grand and Utah has been part of this neighborhood for over 100 years. We are an active partner in the stability of the local community.


Our parish convent at 3522 Utah Street is now available for other uses.
