- **15<sup>th</sup> Ward Aldermanic report** - Alderperson Megan Green( [megan@meganellyiaagreen.com](mailto:megan@meganellyiaagreen.com) /314-591-9587)

- *No report – Alderman absent.*

- **Neighborhood Improvement Specialist/ NSO, Katie Wolf** ([wolfk@stlouis-mo.gov](mailto:wolfk@stlouis-mo.gov) or 314-657-1374)

- *Katie reports she has been doing an informal street light survey to check for lights that are out.*
    - *Please report out street lights to Citizens' Service Bureau. Report out alley lights to Ameren – be sure to note pole number.*
    - *She has noticed some residences have motion detector lights in the alley that light up when any motion is detected and she encourages the use of this type of lighting.*
    - *She also wants to make sure any vacant homes are boarded up.*
    - *Report to Citizens' Service Bureau any yard waste, recycling or trash bins that are still full after they should have been emptied.*
    - *She reports that the Forestry Department has hired six new permanent tree trimmers.*

- **SLMPD 2<sup>nd</sup> District update** - Liaison Officer Ed Slade ([edslade@slmpd.org](mailto:edslade@slmpd.org))

- *There has been "an influx of burglaries" in Tower Grove South as well as reports of copper being ripped out of vacant houses. Most of these incidences are happening during evening hours. Prior to this, most of the numbers have been driven by crime occurring in the "wedge" area of TGS.*
    - *P.O. Slade is aware of Rachel Witt's (S. Grand CID Director) concern about increased panhandling on S. Grand. There are a couple of officers dedicated to finding resources for them, however, most of the time, offers of resources have been rejected.*
    - *If anyone is approached by panhandlers at an ATM, this is considered "aggressive begging" and should be reported to 911.*
    - *There are also reports of individuals sleeping in Ritz Park or in doorways along S. Grand. These incidences should be reported to police via the non-emergency phone number, 314-321-1212.*

- **Speaker: Bill Reininger, Director, Tower Grove Park** ([www.towergrovepark.org](http://www.towergrovepark.org))

- *They have received almost 1300 survey responses on their Master Plan.*
    - *There is an interactive map, powered by GPS, on their website which maps all 6800 trees in the park.*
    - *About 15,000 tulips have been planted and 2000 lbs. of grass seed have been sown on the fields throughout the park.*
    - *They now have a part-time employee focusing on volunteers and educational programs.*
    - *The Gate House at the Kingshighway entrance will be turned into an education center.*
    - *Improvements have been made to the Stupp Center which can be rented out.*
    - *An anonymous donor gave \$485,000 for improvements to the horse stables.*



- *In response to a resident's question about spraying chemicals near trees, he stated that the areas around trees are sprayed only once per year, in the spring. He encouraged the resident to call him to discuss the matter further.*
- *In response to an inquiry about a dog park, he stated that many of the survey responses were against creating a dog park because the necessary fencing would detract from the park's aesthetic and there are restrictions to maintain the park's historical district status.*

  - **Safety Committee – Ryan Barry ([safety@towergroveheights.com](mailto:safety@towergroveheights.com))**
    - *Many thanks to everyone who attended, donated to or volunteered to help with the Safety Committee's well-attended "Pizza for Cameras" fundraiser on November 4 which earned over three times the initial goal. (Details to follow.) The fundraiser was the culmination of two years' work by the committee. Our plan is to install cameras on houses whose owners have volunteered them on intersections along S. Spring and Gustine. SLMPD Cadet, Andrew Ladage, has volunteered to help with the installations. We are leaning towards purchasing Arlo Pro2 cameras with a solar panel. These cameras have 2-way audio and are cloud-based (no local storage). Passwords do not have to be shared. We hope to start installation after the first of the year. Barbara Gilchrist has volunteered to write Memos of Understanding (MOUs) for homeowners outlining expectations.*
    - *We also raised \$170 for the family of retired SLMPD officer, Sgt. Ralph Harper, who was recently killed in a carjacking incident in Tower Grove South.*

    - *The official annual Block Captain training on November 12 was postponed due to inclement weather. The training will be rescheduled at a later date.*

**\*Expense, Income, and Transfer Notes:** **January:** \$620 was transferred from PayPal to the Commerce account. The *Other* income was from the Schnucks eScrip program. **February:** The *Misc.* expenses were \$164.88 for the purchase of sign holders (for announcement monthly meetings and other events), \$75.00 for vendor-fee contribution to Tower Grove Pride, and \$18.95 for a plaque for the 2017 Neighborhood Hero. The *Other* income was from the Schnucks eScrip program. **March:** \$115 was transferred from PayPal to the Commerce account, and \$1000 was transferred from Capital One to the Commerce Account. The *Donations* were \$650 to South Grand Cultural Alliance and \$250 to Tower Grove Farmers Market. The *Other* income was a donation (\$1.00) and the Schnucks eScrip program (\$3.29). The *Membership Dues via PayPal* reflect that \$10 ended up being refunded in April. **April:** The *Other* income was from the Schnucks eScrip program.
