The Shaw Neighborhood Ownership Model (ShawNOM) invites you to a special “Stop The Bleed” event, in coordination with [Stopthebleedstl.org](http://Stopthebleedstl.org) to learn the basics of what everyone should know to be able to control serious bleeding, in 1 hour.

No matter how rapid the arrival of professional emergency responders, bystanders will always be first on the scene. A person who is bleeding can die from blood loss within five minutes, therefore it is important to quickly stop the blood loss. Those nearest to someone with life threatening injuries are best positioned to provide immediate care.

This class combines a lecture with hands on practice in how to give Trauma First Aid as a bystander on the scene when someone has been seriously hurt. This course comes with Bleeding Control 1.0 certification through the American College of Surgeons as well as the opportunity to purchase low cost Trauma First Aid Kits! Ages 14+

## Collaborate – To Connect Communities

The League brings communities together to share, learn, and grow for the benefit of the entire St. Louis region. Some examples of this collaboration include:

- By 2022, all members of the Municipal League of Metro St. Louis will have state or nationally-accredited police departments, to ensure the highest standards of policing across all parts of the region, and establish St. Louis as a national leader.
- Two shared dispatch centers allow municipalities access to state-of-the-art communication technologies that improve public safety and reduce costs. Eleven cities are already saving more \$750,000 annually while providing improved services for residents.
- The League was instrumental in initiating the E-911 Proposition in 2009 to establish a St. Louis County-wide communication system that can identify the location of a cell phone when calling 911 calls and replaced the countywide emergency siren system.

## Educate - To Develop Strong Leaders

As a resource for local elected officials, the League provides professional development, training and education, and networking to help them better serve our region's residents.

The League's training academy educates members on the sunshine law, ethics and conflict of interest, budgets and financing, parliamentary procedures, purchasing and contracts, and planning and zoning.

The League holds regular meetings each year, featuring guest speakers of interest to our members, and we regularly give presentations to other organizations on local government issues.
