- **15th Ward Aldermanic Report**

- *In Alderwoman Green's absence, President Gilchrist reported: Ward Business/Constituent Service: the striping that was recently applied to Gustine is coming up and will be repaired when temperatures allow. One of the Gustine intersections is not finished.*

- *Board of Aldermen Business: The half-cent sales tax initiative stalled in committee and probably won't be on the upcoming ballot.*

- **SLMPD 2nd District Liaison Officer, Ed Slade (edslade@slmpd.org) (see attachment)**

- *The number of robberies has crept up over the last week or two.*

- *Be cognizant of your surroundings while walking in the neighborhood, and when exiting your vehicle. If you notice suspicious individuals near where you park, drive around the block until they have moved on. Avoid sitting in your vehicle checking your phone for long periods of time.*

- *Would-be robbers often knock on doors to check if anyone is at home before breaking in so don't ignore knocking. If you don't feel safe opening the door, inquire through the door what the knocker is seeking.*

- *In response to a question about the difference between gunshots and fireworks, Officer Slade said that a trained ear is about one of the only ways of differentiating the two. Best to call it in if you are not sure. SLMPD is more likely to follow up when there are multiple calls for the same incident.*

- *Reported that our area is deprived of much needed tax revenue when residents cross state lines to renew their license plates. Please notify him when you notice this happening. He also asks that we notify him of any vehicles without plates that are continuously parked on public property in the neighborhood.*

- *Permits are required for construction waste/debris dumpsters. Contact him if you know of expired permits that are still being used.*

- *SLMPD will conduct a Safety Workshop at Bishop DuBourg High School on March 11. There will be vendors there to answer questions about their products/services. (see attachment)*

- **100 Neediest Cases Report (2016)**
 - Chair Ellen Wilson was not in attendance but the following information was conveyed in her absence: “We had presents for all family members, about \$240 per family in various gift cards and about \$950 per family in utilities.” In all, about \$2,260 was raised. Many thanks to all who contributed!
- **Safety Committee**
 - A new TGH safety committee was formed in November. Stephen Gregali is working on setting up the first meeting. Everyone who signed up for the committee will receive an email about the meeting time and location.
- **Social Committee**
 - Chair Vicky Dean was not in attendance, but it was announced that committee meeting is scheduled.
 - Heights Nights will begin in March.
- **Block Captain Report**
 - Debra Knox Deiermann reported on the first Block Captain meeting of 2017. (see attachment)
- **Treasurer Report**
 - Treasurer Rick Stein provided the annual 2016 Financial Statement (see attachment). As noted, the total contribution amounts for 100 Neediest Cases were higher than reflected in Ellen Wilson’s report because she did not have the final tabulations.
- **Featured Speakers**
 - **Mark Abbott, SLACO Board Member**
 - Mark introduced himself as TGHNA’s representative on the St. Louis Association of Community Organizations board. He has lived on 3600 Hartford since 1988. He teaches at Harris-Stowe State University and is a historian by training. Presently, he is preparing a paper on the Tower Grove South and Tower Grove Heights neighborhoods.
 - He reported that SLACO is involved with Proposition NS which will be on the ballot in April. This proposed ordinance would generate monies to stabilize a number of vacant Land Reutilization Authority (LRA) buildings each year. <http://www.slaco-mo.org/vacancy.html>
 - It was noted that Proposition NS is a ballot issue about which the Association does not take a position. The presentation was for informational purposes only and members were encouraged to become educated about the issue before voting.
 - **Nancy Thompson**
 - Nancy is the retired Executive Director of SLACO. She is presently involved with the “New Partners for Smart Growth” conference. This three-day conference will include over 80 plenary keynotes, implementation sessions, breakouts, workshops and networking opportunities for participants. For more info: www.newpartners.org. - The Block Captain training was held in November 2016. A formal training packet was created and distributed. There is now a Block Captain for every block in Tower Grove Heights and some blocks even have co-captains.
- The first Block Captain meeting of 2017 featured Battalion Chief Steve Simpson, Lambert St. Louis International Airport who discussed fire safety.
- Until a new Neighborhood Improvement Specialist (formerly known as Neighborhood Stabilization Officer) is named, we have two new interim NISs, who are helping out in Ward 15:

Michelle Boston-David (NIS for Ward 8) will handle quality of life issues for Ward 15; and

Mark Washington-McLean (NIS for Ward 10) will handle nuisance and problem properties and attend neighborhood association and Block Captain meetings in Ward 15, when available.

The job opening for the Ward 15 NIS has now closed and a permanent NIS is expected to be named by March.

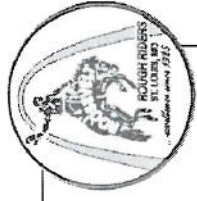

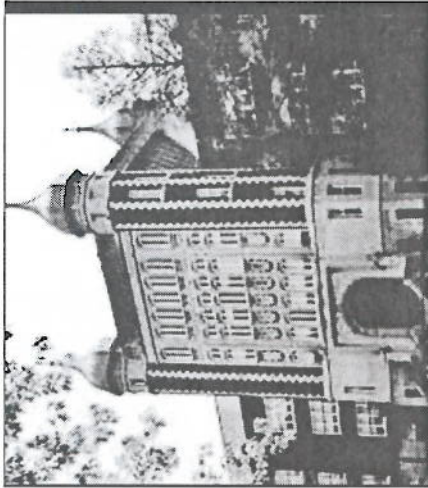

INITIATIVES:

Football Breakfasts

Provide a hot, homemade breakfast for the JV and Varsity football teams before home games on Saturdays.

Approximately ninety percent of the school population is eligible for free/reduced lunch. The kids receive consistent nourishment by the school during the week. We became aware our athletes may not be receiving the proper nutrition at home on the weekends. For their health and well-being this program was implemented.



AFTER SCHOOL PROGRAM

The After School Program provides constructive learning and enrichment activities for students in a supervised setting.

After school clubs like Debate Team, Crafting, Step Club, Gardening and Tutoring help students build stronger relationships with positive adult role models. Roosevelt staff members serve as moderators of the clubs. Participation in the program reduces the likelihood of youth-related crime, improves student attendance at school, in addition to improving academic performance.

The RCC provides overall supervision and direction for the program, including monitoring, record-keeping and deadline management. Snacks are provided to participants.



SCHOLARSHIPS/ MENTORING PROGRAM

RCC assists with fundraising for the "1960's RHS Alumni Scholar-Athlete Scholarship" and supports activities at Roosevelt High like the "Conscious Choice" program for young women.





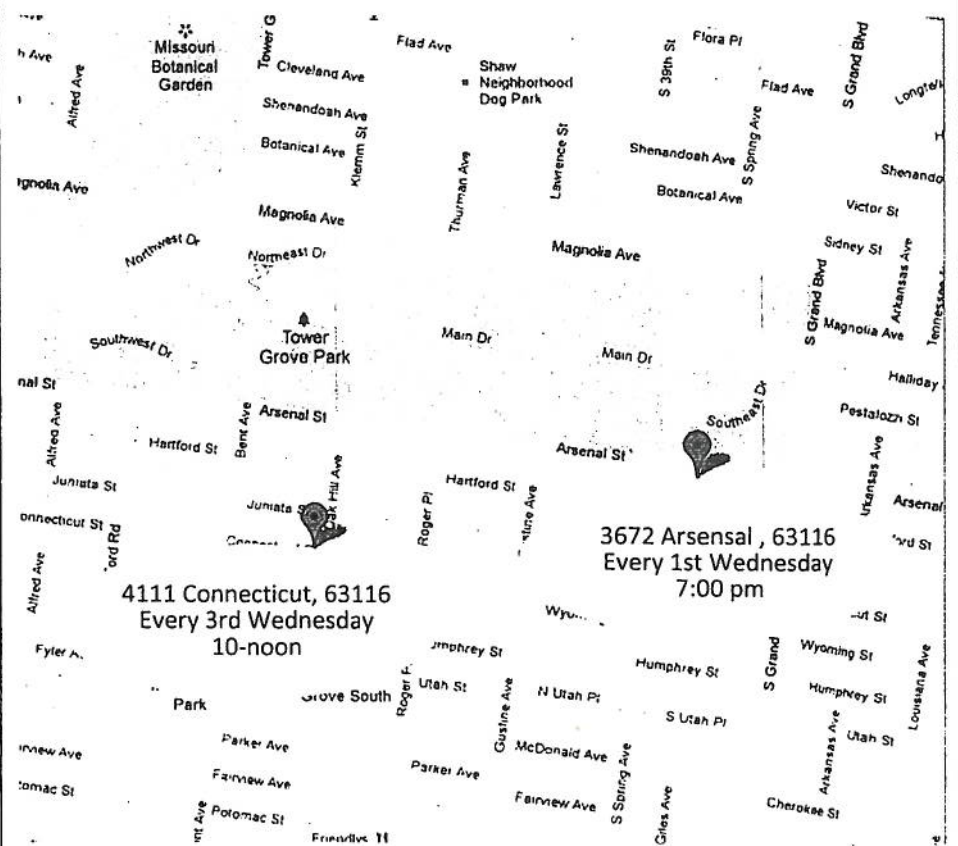
