



## Membership Information and Registration Form

The Tower Grove Heights Neighborhood Association invites you to become a member! The boundaries of the Neighborhood are South Grand to Gustine and Arsenal to Utah. There are two ways to join TGHNA which is a 501(c)(3) organization:

1. You may join TGHNA online by going to: [towergroveheights.com](http://towergroveheights.com) and clicking on the "Neighborhood Association" tab. From the drop-down menu, click on "Neighborhood Association Membership." Membership fees for online registrations must be paid through PayPal or credit/debit card.

2. To join by mail, complete membership registration form on the back of this sheet and mail to P.O. Box 160069, St. Louis, MO 63116. Please make your check payable to: Tower Grove Heights Neighborhood Association (or TGHNA).

### Annual Membership Fees and Levels

Individual Membership - Annual (\$10): To be eligible for membership at this level, an individual must reside in or own property within the boundaries of the Tower Grove Heights Neighborhood. Individual members are entitled to one (1) vote at TGHNA meetings, stand for office and/or serve on or chair a committee in accordance with the provisions of the bylaws.

Household Membership - Annual (\$15): This level of membership provides for a single annual membership fee to cover two (2) people residing in or owning the same residence in TGH. Each of the individuals is entitled to one (1) vote at TGHNA meetings, stand for office and/or serve on or chair a committee in accordance with the provisions of the bylaws.

Associate Membership - Annual (\$10): This level is for individuals who have an interest in the Neighborhood but who don't meet the requirements to be an individual member. An Associate Member may attend Neighborhood meetings, serve on or chair a committee, but may not vote or be an Officer.

Business Membership - Annual (\$25): This level is for local businesses that have an interest in TGH. A business must maintain a physical presence in the Neighborhood in order for their appointed representative to have one (1) vote and stand for office. Memberships for businesses located outside the Neighborhood are not eligible to vote or stand for office.

### Lifetime Membership Fees and Levels

Individual Membership - Lifetime (\$100): At this level, an individual may become a member of the TGHNA for his/her lifetime. A Lifetime Member must meet the requirements of an individual member to be eligible to have one (1) vote, stand for office and/or serve on or chair a committee. If/when the individual no longer owns property or resides in the Neighborhood, they retain membership and can attend meetings, serve on or chair a committee, but can no longer vote or be an Officer.

Business Membership - Lifetime (\$500): This level provides for a business membership for the lifetime of the business. If the business transfers ownership, the membership shall carry over to the new business owner(s); however, they must maintain a physical presence within the Neighborhood in order for their appointed representative to vote.

Only members who meet the requirements for voting privileges as described in the bylaws and are current in membership fees may vote at Tower Grove Heights Neighborhood Association meetings. Voting eligibility for newly-admitted members will commence 60 days following receipt of membership fees. Bylaws can be found at [towergroveheights.com](http://towergroveheights.com). TGHNA is a 501(c)(3) organization. Membership fees are tax deductible as allowable by law.
